Myers to celebrate 100th birthday

Lifelong Richland County resident, Harold Myers will turn 100 on June 8. I wonder if Harold ever imagined himself living to be 100 years old.

Growing up poor during the Depression, he never went hungry. Harold was born on June 8, 1922, in Lexington. He remembers his mom would put a dime in his birthday card each year. They always found a way to make ends meet. Whether it was digging up potatoes, mowing lawns or working a modest paper route, their family always found a way to make a nickel stretch.

After working his paper route in 1939, he would make 20 cents a week. He placed his earnings into an old cigar box and maybe had enough left over to buy a few ice cream cones. They didn't really have time for hobbies back then. Their hobbies included some hard work with a side of more hard work.

He remembers growing up on Delaware Street, walking to school, and coming back home for lunch. He enjoyed playing basketball and baseball during his school days.

With just six kids in his first-grade class, he ended up graduated from Lexington High School with 31 students. Only two remain (Harold and one other gentleman). He went on to work at Mansfield (Continued on Page 5)

Memorial Day activities planned

The veterans buried in the Old Soldiers Grounds in Mansfield Cemetery are being honored with a special project dedicated to the memory of Stanton Grubb, who helped with the Veterans Honor Grounds project and was ready to help with this one.

The Richland County Veterans Service Commission, in conjunction with the Mansfield Cemetery and Purdy Construction, has been working on the project since October 2019.

At the beginning, there were 125 veterans without headstones (after research there were 148) and now each and every one of them has a headstone, flag holder and new foundation.

A dedication ceremony for the Old Soldiers Grounds Renovation Project will be Monday, May 30, at 2 pm.

2022 Memorial Day activities include the placing of flags in Mansfield Cemetery on Saturday, May 28, at 9 am. Volunteers can help place flags on veterans' graves. The group will meet by the van and trailer at the Veterans Honor Grounds.

The Avenue of Flags Ceremony will be held at Mansfield Memorial Park on Sunday, May 29, at 1 pm and the parade is scheduled for Monday, May 30, at 10:30 am. The parade begins at the 5-way intersection of Park Avenue West and Marion Ave. and continues down Park Avenue to the gazebo on the square. There is a memorial service at the gazebo immediately following the parade.

Flags will be picked back up on Saturday, June 4 at 10 am. The group will begin by Vasbinder Fountain near the Old Soldiers Ground. All volunteers are welcome.

The Story of Charles Mill

Most folks know where Charles Mill Lake is. Does it ever make one think it was named after a mill? Yup, you're right, Here's the story.

In 1818, Elijah Charles built a sawmill on what later became known as the Charles Mill site. In 1835, Elijah died and his son Issac used the sawmill to furnish the boards and timbers for a grist mill.

For a quarter of a century, Issac ran both mills successfully, notwithstanding the litigation from the courts. Issac had more than his share of trouble with his neighbors. The dam for his mills was not far from where the Mansfield-Olivesburg Rd. crossed the Black Fork. There was insufficient fall to provide the necessary power to operate the mills.

As a result, the dam that Charles built would back up water as far as three miles, causing the flooding of water into the marshes which became to be believed as unhealthy by neighbors.

A man named Mr. Lee brought a lawsuit against Issac Charles which dragged on for years. Lee eventually won the case which caused Charles to lower his dam by one foot. The mill dam and head race powered a ten to twelve foot water wheel at the mill.

Isaac Charles had a son who he also named Issac. In 1868, Issac Sr. moved to Bluffton, in Allen County, where he lived for several years. He was murdered by his son for reasons unknown. He was convicted and sentenced to life in prison.

The next owner was David Linn. He had an interesting background. His grandfather was David Rowlands, a staff officer under George Washington during the Revolutionary War.

David Linn moved to Ohio in 1835. David and his brother Jacob purchased the mills shortly after the Civil War. The mills were in disrepair and required expensive refitting. They operated them under the name of D. Linn & Company. Although David was a component miller but he had one flaw, his gullibility and willingness to trust people. He also found himself in litigation with some of those he helped, which prompted people who owed him money to avoid him. In his diary found years ago, he had listed the names of people who owed him money or defrauded him. Listed were seven as "now dead" and two others still living. Two of them were members of the Charles family.

The mill was rebuilt in 1845 but later in 1900 it was dismantled and re-erected in Lucas. No longer water powered, it had served several tenents until it burned down in 1957.

In 1935–'36, the Charles Mill Dam construction erased nearly all traces of the mill site. But one very important bit of history did survive. The Charles Mill Dam and Lake have a name salvaged from history.


Tire and Rubber after graduation for seven months, before being drafted into the Army.

In the Spring of 1941, young boys like himself had to register for WW II. After being drafted, Harold served in the Army for 37 months. He worked as a quarter master in the supply division. What most people don't realize is that the support units for the Army makes up a good portion of it. Preparing food and having clothing ready was a

vital part that went on behind the scenes. Harold never really got lonely. He saw it as an adventure, and he didn't mind being that far away from his modest home town. He met so many amazing young men. The comradery is what he cherishes most about his Army days.

"They sure knew how to keep us busy! Between 6:30 am roll call, they had things scheduled for every hour of the day. When it came time to go to bed, we were all ready! I went into the Army weighing in at 145 pounds and came home weighing exactly the same. There was no obesity in the army," Harold said.

After growing up in a small rural town of Ohio, meeting all sorts of people from around the world was fascinating for teenage Harold. "I met a polish boy from Pittsburgh, a boy from Brooklyn, NY, a Jewish



On May 28, Harold will celebrate another amazing milestone. He and his bride, Margaret, will celebrate their 72nd wedding anniversary! Margaret also remembers growing up poor, in Plymouth. They didn't have electricity or many things at all. Harold met Margaret at Mansfield Tire and Rubber in 1947 after returning from the war. Margaret was a secretary and Harold worked as an accountant in the Cost department. He would stop by a visit Margaret's desk at work a little too much.

Margaret's brother-in-law was the controller, and he didn't particularly like Harold coming around so much. They went onto date for three years and got married on May 28, 1950. Margaret said, "there will always be peeks and valleys, and differences of opinions in marriage, but we always found a way to make things work."

Harold went on to work at Mansfield Tire and Rubber for 32 years, plus another 11 years at G & L Supply, and finally 22 years with Interstate Optical. He was finally forced to retire at the age of 90 years old. His boss pulled him into his office and said, "I think it's time for you to retire." Harold obliged, but I think he would still be working today if allowed.

Margaret has gladly given up driving, but not Harold! He still drives, even though Margaret thinks he should give that up too. "He's a good driver, but he makes me scream sometimes in the car!"

Harold loves to read and watch sports, while Margaret loves to listen to music. She appreciates a slower lifestyle, while Harold has tended to move at a faster pace throughout his life. They certainly balance one another out perfectly, in my opinion.

"Just the other day, he was trying to get by me in the kitchen and wanted me to get out of his way, and I just said, stop it right now, Harold! I don't like your tone. He stopped right there an apologized."

When asked the secret to a long-lasting relationship, Harold likes to say, "at the end of the day, you can always say these simple words, 'honey, you're right."

Healthy communication and a kindness have kept these two in love for over 75 years. "He's been really easy to live with. I've never had to worry about a thing. 



Southern New Hampshire University (SNHU) has named students to its Winter 2022 President's List.

Full-time undergraduate students who have earned a minimum grade-point average of 3.7 and above are named to the President's List. Hosting an exchange student is a way to share what's special about America and to gain an international friend."
