Quincy's Refuge creates a place for second chances

The little girl quietly pulled her coat tighter as she stepped toward the fence. Just weeks earlier, grief had left her withdrawn after losing a close family member. She rarely wanted to leave home, let alone spend time around strangers.

Then one of the refuge's rescued horses quietly walked over to meet her.

The gentle interaction lasted only a few moments, but something began to change. Today, the girl eagerly returns to Quincy's Refuge, participating in activities, smiling more often and slowly rediscovering joy.

"It's amazing what these horses can do," founder Ronda Robey said.

For Robey, moments like that are exactly why Quincy's Refuge exists.

The faith-based 501(c)(3) nonprofit near Perrysville provides a place where rescued horses and people carrying life's burdens often find healing together.

Its story, in many ways, began with healing.

Robey retired after nearly 30 years serving families through Werner-Gompf Funeral Services. A licensed funeral director and licensed social worker, she thought retirement might finally slow life down.

Instead, God had other plans.

"I've loved horses my whole life," Robey said. "I got my first pony when I was eight years old, and I've never been without them."

Years ago, Robey and her family began helping another farm that offered children's programs. When that ministry came to an end, families continued reaching out, asking if their children could still come spend time around the horses.

A friend encouraged Robey to become a nonprofit so people could financially support the ministry. She admits she struggled with the decision for quite some time.

"I finally had a talk with God," she said. "I told Him to either take the horses away or use them for His glory to reach others for Christ."

Not long afterward, Quincy entered her life.

The sorrel Quarter Horse gelding had been rescued from a kill pen. Years of being ridden too hard had left him physically broken,

with a painful knee. Emotionally, he seemed defeated.

"He stood with his nose in the corner," Robey recalled.

With patience, gentle care and love, Quincy slowly began trusting again.

"He went from being depressed to my best friend."

After Quincy passed away, Robey found herself reflecting on the refuge he had discovered at her farm.

Then she came across Psalm 91:2.

"I will say of the LORD, 'He is my refuge and my fortress, My God, in Him I will trust.'"

"The name just came together," Robey said. "Everything came together because of Christ."

Today, Quincy's Refuge has become exactly that — a refuge.

Approximately 20 horses, ponies and miniature horses now call the property home, along with about 50 cats, 11 chickens, three dogs, guinea pigs, a duck and several other rescued animals.

Many of the horses were rescued from kill pens through Julie Copper and Copper Horse Crusade before finding permanent homes at the refuge.

Every animal has a story — perhaps none more inspiring than Peaches. The eight-year-old palomino Paint Quarter Horse lost both

The event is free to the first 200 (max) manufacturing retirees in north central Ohio.

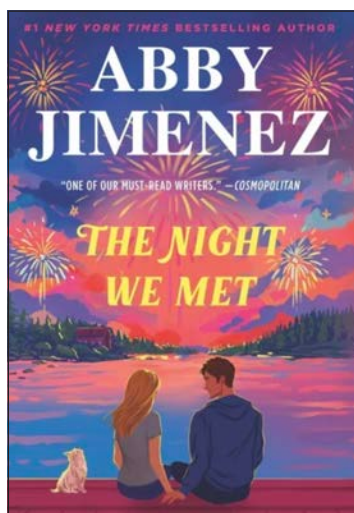

State Representative Marilyn John (R-Richland County) recently announced that the Ohio History Fund grant application is now available.

Grants are used to support local history projects, including the rehabilitation of National Register-listed historic buildings, museum collection storage initiatives, educational programs and more.

"Richland County has a strong connection to Ohio's history through its historic buildings and infrastructure, and I hope our community will benefit from these preservation efforts," said Rep. John.

Residents can apply for Summer Crisis Program assistance

The Ohio Department of Job and Family Services and Ohio District 5 Area Agency on Aging, Inc. are once again offering assistance to help Ohio's families stay cool during the hot summer months.

From July 1 through Sept. 30, income-eligible Ohioans can receive assistance in paying their electric bill, purchasing an air conditioner or fan, or making repairs to their central air conditioning unit through the Ohio Department of Job and Family Service's Home Energy Assistance Summer Crisis Program (HEAP).

The Summer Crisis Program assists low-income households and those that have a disconnection notice, have been shut off, are trying to establish new service on their electric bill, require air conditioning, or those with a household member age 60 or older and/or a household member with a documented medical condition.

Qualifying medical conditions can include lung disease, Chronic Obstructive Pulmonary Disease, asthma, and others.

To qualify for assistance, Ohioans must have a gross income at or below 175 percent of the Federal Poverty Guidelines for a family of up to seven members, and 60 percent of the State Median Income for a family of eight or more members. For a family of four, the annual income must be at or below \$57,750.

Last year, the Summer Crisis Program assisted more than 55,000 households in Ohio, providing a total of \$12.4 million in benefits.

To apply for the program, clients are required to schedule an appointment with your local Community Action Commission.

Clients need to bring copies of the following documents to their appointment: copies of their most recent energy bills, a list of all household members and proof of income for the last 30 days or 12 months for each member, proof of U.S. citizenship or legal residency for all household members, proof of disability (if applicable) and physician documentation that cooling assistance is needed for a household member's health.

Ohioans enrolled in the Percentage of Income Payment Plan Plus (PIPP) program who meet the above criteria may also be eligible for assistance, or central air conditioning repairs, or may receive an air conditioning unit and/or fan.

eyes after years of neglect and severe malnourishment.

Most people would assume blindness would make her fearful.

Instead, she's one of the first horses to greet visitors.

"When she hears the kids' voices, she comes right to the fence so they can pet her," Robey said.

Peaches has become one of the ministry's greatest teachers. Robey often reminds children, "If she's having a good day without any eyes, we can choose to have a good day too."

"Every one of our animals teaches us something."

Those lessons are especially evident through Quincy's Kids, a program serving children in kindergarten through fifth grade who may be facing autism, ADHD, Reactive Attachment Disorder (RAD), abuse, neglect, abandonment or other difficult circumstances.

Children learn to brush, feed and care for the horses while participating in Bible lessons, obstacle courses, crafts and seasonal activities.

But Robey says the biggest changes often happen quietly.

She remembers the young girl struggling with grief who gradually opened up.

She also recalls one boy who barely spoke when he first arrived.

"He was very shy," Robey said. "Now he looks forward to coming. He talks. He gets involved. You can see the difference."

Adults experience that same joy.

Groups from Dale Roy and local developmental disability programs regularly visit, and Robey says watching them interact with the animals is one of the highlights of the ministry.

Running Quincy's Refuge is rewarding, but it is also demanding. Most mornings begin with prayer and Bible reading before hours of feeding animals, administering medications, cleaning stalls and caring for the property. Summer chores often take two hours before ministry activities even begin, while winter mornings can take twice as long.

"It's a lot of work and the financial needs are equally significant," Robey said.

Veterinary care, medications, grain, hay, bedding, hoof care and routine maintenance require thousands of dollars every year.

The refuge also needs volunteers willing to help with fencing, pasture maintenance, repairs, finishing the tack room and caring for the animals.

Still, Robey says she wouldn't trade this calling.

"My dad was a pastor," she said. "I never thought I'd become a social worker or funeral director. Looking back, I see that God was preparing me for this all along."

She knows not everyone shares her faith, but she doesn't apologize for making Christ the center of the ministry.

"We have Bible lessons and talk about Jesus," she said. "That may not be what everyone wants to hear, but that's what our program is centered around."

Looking ahead, Robey dreams of making Quincy's Refuge increasingly self-sustaining so no horse—or child—ever has to be turned away.

Her vision reaches far beyond the fences of the ranch.

She hopes rescued animals and hurting people alike will continue finding hope together, discovering that brokenness doesn't have to be the end of the story.

If Quincy could see the refuge today, Robey believes he'd be doing exactly what he loved most—wandering the pasture, making new friends and welcoming every frightened horse that arrived.

His legacy isn't a ranch that bears his name.

It's a place where broken horses help heal broken hearts.

Mount Gilead will host recycling day

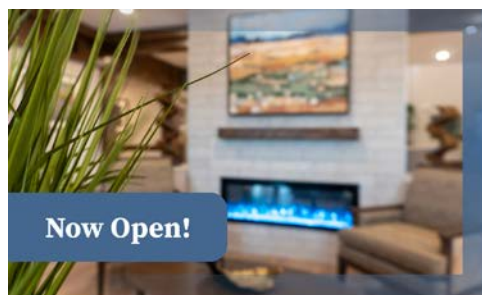
Recycle chemical containers and agricultural tires for free at the Agricultural Recycling Day on Sat., Aug. 1. The event will run from 8 am to 12 pm at the Morrow County Fairgrounds, 195 S. Main St., Mount Gilead.

This joint effort offers local farmers and commercial applicators a single, convenient location to clean out their shops, recycle plastic containers, and safely dispose of old agricultural tires at no cost. No pre-registration is required to participate.

The agricultural container collection is part of the national Ag Container Recycling Council program, which has successfully recycled more than 236 million pounds of agricultural plastic since 1992. To be accepted, containers must be made of rigid high-density polyethylene (HDPE) up to 55 gallons (resin #2 or 7) in size and have previously held crop protection or agricultural products. All jugs must be triple-rinsed (or pressure-rinsed), completely dry, and free of residue inside and out. Caps and booklet labels must be removed and discarded prior to drop-off. Consumer, home, or garden pesticide containers are excluded.

Simultaneously, agricultural tires of any size will be accepted. All tires must be off the rim and reasonably free of mud, water, and heavy debris to be accepted for recycling.

This event is made possible through the Ohio Environmental Protection Agency and the Ag Container Recycling Council and hosted by Delaware, Knox, Marion and Morrow Solid Waste District, Morrow County Farm Bureau, Morrow County Soil and Water Conservation District and OSU Extension - Morrow County.

Travel teams offer athletes year-round play

Last week, we started to learn how the local Ohio Lasers Green Softball Team was formed.

This week, we will learn about modern technology and how it has blazed a trail with the new modern era of travel teams.

Each week on social media I see numerous basketball camps, soccer clinics, 7-on-7 football drills, baseball and softball tournaments and traveling all-star teams.

These teams are growing in popularity year-after-year and is big business, costing roughly \$40–52 billion dollars in the U.S. nation-wide each year.

Things sure have changed since my time growing up in the 1970s.

I was a young sprout of about nine growing up a few miles west of Findlay in the Cory-Rawson school district when my little league career was birthed.

I still remember sitting in school waiting for my last class to let out in the third grade so I could practice after school. The field was in view of my classroom, which of course added to my excitement.

My dad was the coach and we played local rural teams. I still have good memories of some of my games. There was no t-ball, coach-pitch or pitching machines.

Back then there were various age levels, minor and major leagues, but no travel teams. At the end of the regular 8–10 game season, there would be a local All-Star team that was selected from the coaches' voting. They would play another week or two, and that would end our season and summer would begin.

As the years progressed, that was the norm for our society.

But let's fast forward to the early 1990s which marks the rise of one of the first travel teams in the Richland County area — the Johnny Appleseed Baseball Club (JABC).

Athletes were selected from the local in-house little league teams and played 4–6 tournaments locally after the regular little league season had ended. This gave the kids a few more tournaments to play in and would wrap up a few weeks before school would begin.

Around that time I followed in my dad's footsteps and coached my son when he was nine. We played our typical little league schedule of 10 games.

As the year 2000 was approaching, travel teams became a familiar term as the area now had three travel teams. I was blessed to be able to coach one of them.

Since then, travel teams have grown exponentially and there are now various levels including national programs, which are top teams with professional coaching and national schedules.

The next level down would be regional teams which also have highly skilled talent, with high-level coaching and college prospects.

There are also still local travel teams with good talent in local areas competing at mostly state and local events.

I think one of the most amazing items of interest is the way technology has been integrated into the sports world. Scorekeeping has come a long way.

Back when I was coaching, scoring was kept with paper and pen. Going to the dentist seemed less painful than trying to bribe someone in the crowd to volunteer to "keep the scorebook."

In 2010, electronic scorekeeping came on the scene. The technology was called "GameChanger" and trust me, that's exactly what it is.

The app keeps score and stats in realtime as the game is played. This allows parents, coaches and sportswriters to sign-up to access scores for free or by paying a small fee. The ability to keep score this way helps travel teams immensely.

Travel teams can encounter various tournament formats as opposed to the regular in-house or OHSAA regular season rules. Some tournaments have specific rules for batting order and even substitutions which can vary from the norm of the regular season.

Ohio Lasers Green Softball Team 16 U head coach Chris Clapper, recalled one specific tournament that had a unique pitching rule.

"We played down in Tennessee a couple weeks ago. They have a rule that you cannot step backwards before you pitch. It's not a rule in Ohio, but I think it's a rule in the State of Tennessee, and they just abide by it."

The batting line-ups can vary as well.

"During our OHSAA season in high school you bat only ten. With some travel tournaments, you can bat through the whole order."

Since the travel leagues take place during the summer months, they can serve many purposes. It keeps the players in shape during the off-season and gives college scouts an opportunity to observe players.

As for the scouting benefits, Clapper said one scout came halfway across the country to watch a player on one of the other teams.

"I usually know when they are attending the tournament. They typically give me a call and I can accommodate my line-up accordingly so the scout can observe the player."

"I had a girl going to the College of Wooster and a scout was coming to watch her. The scout asked me what game she was going to pitch and we planned around her visit."

"We also have data for the scouts at the game if they need information on a certain player. We have stat sheets with the player's photos and GPA on it. The sheet has a QR code for each player. If you scan that QR code, it takes you to that player's individual stats."

"We have these hanging up on the fence behind the catcher and the scouts can just grab the sheet."

Travel teams can give athletes a leg-up, not just by keeping them conditioned, but also when they are looking toward the future.

Balderson bill to strengthen grid and protect ratepayers approved

The Energy and Commerce Committee held a full-committee markup featuring Congressman Troy Balderson's (OH-12) latest effort to lower costs for Ohioans and strengthen the long-term reliability of America's growing electric grid.

Approved by a vote of 47–0, the Load Forecasting Enhancement Act strengthens electric grid planning by giving states and utilities the tools they need to better project future power demand. Accurate load forecasting helps prevent the underbuilding of the electric infrastructure and generation needed to maintain grid reliability. Just as importantly, this bill also helps prevent the overbuilding of unnecessary electric infrastructure for speculative projects that can ultimately increase costs for ratepayers.

The act would direct the Federal Energy Regulatory Commission (FERC) to convene regional joint boards with state public utility commissions to study and identify best practices for electric load forecasting. The legislation would also require FERC to report its findings and recommendations to Congress and require states to consider adopting improved forecasting procedures to support reliable, affordable electric service.

"Our nation is using more electricity each year, and for our grid to meet that growing demand, we need to know where infrastructure investments are needed to keep the lights on and keep America moving forward. By giving states and utilities the tools they need, we can ensure we expand and improve our grid as efficiently as possible — saving Ohio families money while boosting our nation's energy security," said Congressman Troy Balderson (OH-12), Chairman of the House Energy Action Team (HEAT).

"As the electric grid faces increased demand for the first time in decades, it's so important we have engagement across all levels of government to ensure consumers, utilities, grid operators and policy makers have the best and most accurate information," said Jenifer French, Chair of the Public Utilities Commission of Ohio.
